

TERMS AND CONDITIONS

AROUND THE WORLD FOR CYSTIC FIBROSIS CHALLENGE - EQUIPE DE FIBRA

Challenge start date: August 9, 2021.

Challenge end date: November 22, 2021.

Article 2. Participants can choose between two basic modalities: WALKING or RUNNING; or among OTHER MODALITIES, where they can participate with one of their preferences (bicycling, rowing, skating, swimming, etc.).

Article 3. Participants establish, at their own choice, the number of times they will practice the physical activity chosen as part of the AROUND THE WORLD FOR CYSTIC FIBROSIS CHALLENGE, with no minimum or maximum limits of time or route to be traveled individually, throughout the period of the challenge.

Paragraph one: Participants will register for the challenge and pay for participation **only once** and can, for the entire duration of the challenge, include their data in the app. The amount raised by the challenge will be fully allocated to the execution of Unidos pela Vida Institute projects. Article 4. The participant is responsible for the choice of activity (duration, modality, and route) in order to contribute to the overall challenge (40,000km for Cystic Fibrosis). The participant is also responsible for those choices' consequences, respecting all the local laws and the sanitary rules of their region due to the coronavirus pandemic, as well as their physical and medical conditions.

Paragraph one: When performing the activities to contribute distance to the Around the World for CF challenge, being compliant with all the rules established by the World Health Organization (WHO) to deal with the pandemic are followed is recommended: social distancing, use of masks, outside activities, and use of hand sanitizer. Unidos pela Vida Institute is against any and all types of grouping and does not authorize any non-compliance with the rules established by the World Health Organization due to the execution of this challenge and / or any other related activity.

CHAPTER II - REGISTRATION

Article 5. Only people 18 years and older are eligible to register with the Equipe de Fibra app and participate in the AROUND THE WORLD FOR CYSTIC FIBROSIS CHALLENGE, make payment for the registration fee and express their agreement with the rules in these Regulations and whose health conditions are favorable to this end. **Minors can only participate accompanied by an adult, and their route data must be included in the accompanying adult's registration.**

Paragraph One: Registration is personal and non-transferable, and the person is not allowed to be replaced by another person regardless of the reason.

Article 6. Registration is made through the Equipe de Fibra app available in the Apple Store or Google Play.

Article 7. Participants are responsible for the truthfulness of the information provided at the time of registration. If there is proven fraud, the participant will be responsible for a crime of ideological and/or documentary falsehood.

Article 8. There will be no refund of amounts paid in the online system for registration in the challenge, except in the event of cancellation of the challenge, object of art 17 of these Regulations.

CHAPTER III - PRIZES

Article 9. The 100 participants covering the longest distance by the end of the challenge will receive a certificate of participation via e-mail.

Article 10. The FIRST THREE placed in Brazilian territory will receive a trophy, via Post Office.

Paragraph One: For the purpose of prizes, all participants will be included in the general category.

Article 11. There will be trophy awards for the FIRST THREE placed in the CATEGORY PERSON WITH CYSTIC FIBROSIS residing in Brazilian territory.

CHAPTER IV - INSTRUCTIONS AND RULES FOR THE CHALLENGE

Article 12 - Given the pandemic of Covid-19, participants are instructed to do their physical activities in a place with good air circulation, wearing a mask, and stay at least two meters (or 6 feet) from other passers-by, as advised by the World Health Organization.

CHAPTER V - PHYSICAL CONDITIONS OF ATHLETES

Article 13. Every participant must be up to date with rigorous medical evaluation to perform the challenge, being knowledgeable of their health and physical fitness status in order to participate in the challenge. The organizing institution will not be responsible for the physical health of the participants.

Article 14. Participants are responsible for the decision to undertake the activities proposed in the AROUND THE WORLD FOR CYSTIC FIBROSIS CHALLENGE, evaluating their physical condition, performance and judging for themselves whether to continue or not.

Article 15. Unidos pela Vida Institute is not liable for medical care of participants, medical expenses in cases of hospitalization or injuries generated by participation in the challenge.

CHAPTER VI - IMAGE AND COPYRIGHT

Article 16. Participant registering and, consequently, participating in the AROUND THE WORLD FOR CYSTIC FIBROSIS CHALLENGE unconditionally accept and agree to having their image disseminated through photos, films, radio, newspapers, magazines, internet, videos and television, or any other means of communication, for campaign-related informative, promotional or advertising uses, without incurring in any burden for the organizing institution, sponsors and supporters, waiving receiving any income that may be obtained with such rights at any time/date.

CHAPTER VII - SUSPENSION, POSTPONEMENT AND CANCELLATION OF THE CHALLENGE

Article 17. The AROUND THE WORLD FOR CYSTIC FIBROSIS CHALLENGE may be postponed or cancelled at the discretion of the organizing institution, and this decision will be informed to participants through the official website and other official communication channels of Unidos pela Vida Institute, the organizing institution.

Paragraph One: In the event of postponement of the challenge and the consequent disclosure of a new date, registrants will have a period of 7 (seven) days to request refund of their registration fee, counted from the date of notice to the registered participants, under penalty of automatic waiver of this right.

Paragraph Two: In the event of cancellation of the challenge (without disclosure of a new date) registered participants must request reimbursement of the registration fee within 7 (seven) days,

counted from the date of notice to participants, under penalty of automatic waiver of this right. Information about the cancellation will be made through a communication sent by email contato@unidospelavida.org.br, and the request for reimbursement in this case can also be made by this email.

CHAPTER VIII - GENERAL PROVISIONS

Article 18. The organizing institution may, at its discretion or according to the needs of the AROUND THE WORD FOR CYSTIC FIBROSIS CHALLENGE, amend or revoke this regulation, in whole or in part, informing the changes on the official website (www.aroundtheworldcf.org) and by email to registered participants.
